TERMS AND CONDITIONS

TERMS OF PAYMENT: 1% 15 DAYS, NET 30 DAYS FROM DATE OF INVOICE. A service charge will be assessed on all past due balances at the rate of 2% per month (24% per annum), with a minimum service charge of \$5.00. This service charge will be assessed monthly until the invoice is paid in full. All expenses incurred to collect monies due will be paid by the Applicant hereby referred to as Buyer. In the event that a past due account is referred for collection to an agency and or attorney, the Buyer agrees to pay all collection costs, including reasonable attorneys' fees. If legal proceedings are commenced, and Buyer, wants to pay off the amount in full prior judgment or other final resolution, SCS, Inc. shall, in addition to principal and interest, be entitled to be paid attorneys' fees and costs incurred to that point. If legal proceedings are commenced by SCS Inc., Court venue will be Sacramento County or any other proper venue for trial of the action at the option of SCS, Inc.

Buyer agrees fully and promptly to furnish to SCS, Inc. information needed or requested by SCS, Inc. for proper filling out and service of preliminary lien information as required by applicable lien law statutes. If Buyer uses materials purchased hereunder in the construction of a particular work of improvement and or project, Buyer agrees that all monies owed to or received by Buyer in connection with such work or works of improvements shall be held by Buyer in trust for the benefit of SCS, Inc.; shall be segregated from other monies owed to SCS, Inc., and be used only to pay SCS Inc., to the extent that such monies are attributable to the materials purchased hereunder and until SCS Inc. has been paid in full for such materials. Buyer recognizes that it may from time to time be owed money by SCS, Inc. due to contracts or transactions between Buyer and SCS, Inc. which are separate and distinct from the credit sales contemplated by this Credit Application. SCS Inc. has the right to offset those monies based on non-payment by Buyer.

Buyer shall be entirely responsible for the manner in which any materials purchased hereunder are used, or modified by Buyer. Buyer shall defend, indemnify and hold SCS, Inc. harmless against any claims of third parties arising from or relating to Buyer's use or modification or installation of such materials.

A handling charge of 15% will be made for stock material returned for credit. Non- standard items are not returnable. Claims for loss, damage, defect or shortage must be made within five days from date, delivered in writing to receive recognition.

GUARANTY

For value received and the further consideration of any extension of credit that SCS, Inc. may now or hereafter extend to Applicant (hereafter Buyer), the undersigned (hereafter "Guarantor") does hereby unconditionally guarantee and promise to pay SCS Inc. the full and prompt payment of all indebtedness which Buyer has heretofore incurred and or does hereafter incur. Liability of Guarantor shall not be affected by the amount of credit extended, by any change in the form of said indebtedness, by note or otherwise, or by any extension or renewal thereof, nor by the acceptance of any manner of security thereof. Notice of the acceptance of this guaranty, or extension of credit hereunder, or default in payment, of change of indebtedness, the renewal or extension of said indebtedness or any part thereof, or any matter in respect thereto, is hereby expressly waived. SCS Inc., in its sole discretion, may receive, renew, extend, relinquish, substitute, modify or enforce any liens, statutory or otherwise, or security of any kind for payment of said indebtedness together with interest thereon and of any renewals, extensions, substitutions or modifications thereof, all without and in any way impairing or limiting its rights under this guaranty. Any amounts not paid by Guarantor to SCS Inc. under this guaranty, upon demand, and when due, shall bear service charges of 2% per month and or 24% per annum which is subject to change without notice. Guarantor agrees to pay SCS, Inc. reasonable attorneys' fees and all costs and expenses which may be incurred in connection with any legal proceedings initiated by SCS, Inc. for the purpose of enforcing this guaranty and or collection of the indebtedness guaranteed by this guaranty from Guarantor and or Buyer, including but not limited to any proceedings in any state, federal or bankruptcy court. If legal proceedings should be commenced, court venue will be Sacramento County, State of California, unless otherwise agreed to in writing by both parties. The Guaranty additionally is given by each guarantor for the purpose of obtaining the extensions of credit for Applicant and or Buyer. Each guarantor hereto acknowledges that SCS, Inc. has relied on such Guaranty in the extension of credit.
